This year we have returned to purely teacher-led PE lessons using PE Hub as a planning resource. Teachers and pupils alike have greatly enjoyed this change and we have seen a vast improvement in pupil participation and engagement in lessons. There has been much enthusiasm for sporting events and tournaments and even requests for more! Due to the coaching provided by two parents, more pupils have been able to attend (and win!) 'friendlies' in football as well as competitive events in a range of

# How has your school's spending increased pupil PE and sport activity levels?

More pupils fully engaged in PE lessons and sports after-school clubs. Engagement with a local independent secondary school has supported this as they have provided free coaching from staff and senior students.

# How has your school's spending increased school sport participation?

We have spent money on more equipment, including for more minority sports, to enable all pupils to participate and to increase interest for those who have previously been less active. We were able to fund transport to events.

## How has your school's spending increased pupil participation in extra-curricular activities?

A lot of extra participation has come from free clubs offered by staff and students at a local independent school. Purchase of additional resources has supported this.

We will now use SIMS to monitor which pupils participate in which internal and external sporting activities so we can target those who are less active. We will also use our Sports Ambassadors to collect ideas from pupils about preferred sports and activities. Teacher-led PE means that PE and sport have a greater presence in school. We have devoted some of our previous budget and most of our next budget on OPAL to ensure breaktimes provide good opportunities for all pupils to be active.
